Statement of Activities

During the 2024 fiscal year, we received \$ 5,100,412 in total revenue. The vast majority of this support came through generous listener contributions totaling \$ 3,769,112. Investment income of \$ 1,325,174 and other modest revenue supplemented this support.

Our total expenses for the year were \$ 4,620,098. These expenses reflect the costs of operating and maintaining KHCB's broadcast, digital, and ministry outreach. As a result, our net assets increased by \$ 480,314 during the year.

Statement of Financial Position

As of December 31, 2024, KHCB held total assets of \$ 16,967,389 and total liabilities of \$1,464. This resulted in net assets of \$ 16,965,925 providing a strong foundation to sustain and advance our ministry into the future.
